A telephone conference call was held on May 12, 2014, among Judges Lee, Blankenship, and Busch, and respective counsel for the parties. The subject matter discussed was a request by current counsel of Patent Owner, Sharon Fenick, Daniel H. Golub, and Brian P. Gordaychik, to file a motion to withdraw, on the basis that Patent Owner has decided to retain new counsel from Pepper Hamilton LLP. Counsel for Petitioner indicated that Petitioner would not oppose the motion.
