PETITIONER'S REQUEST FOR ORAL ARGUMENT

Pursuant to 37 C.F.R. § 42.70(a), Petitioner, Ford Motor Company submits this Request for Oral Argument on all of the instituted grounds of unpatentability of U.S. Patent No. 8,214,097. Petitioner requests no more than one hour per side of oral argument time. The Board has already scheduled Oral Hearing for July 1, 2015, *see* Paper 23, page 2.

Without intent to waive consideration of any issue not requested, Petitioner requests oral argument on the following issues:

1. Whether Patent Owner's proposed construction for claim 30 should be rejected;
2. Whether claims 30, 31, 35, 36 and 39 are obvious under 35 U.S.C. § 103 over the combination of Severinsky '970 and Anderson;
3. Whether claim 32 is obvious under 35 U.S.C. § 103 over the combination of Severinsky '970, Anderson, and Yamaguchi;
4. Whether claim 33 is obvious under 35 U.S.C. § 103 over the combination of Severinsky '970, Anderson, Yamaguchi and Katsuno;
5. Any motion filed by Patent Owner, including any motion to exclude;
6. Any argument not specifically identified that is raised by Patent Owner at oral argument; and
7. Any issue that the Board requests.
