We, Walter A. Blättler and Ravi V. J. Chari, the undersigned, hereby declare and state:

That we are the joint inventors of the subject matter claimed in the above-identified application, which includes an immunoconjugate comprising the anti-ErbB2 antibody, huMab4D5-8, conjugated to a maytansinoid, e.g., DM1, wherein the antibody is conjugated to 3 to 5 maytansinoid molecules per antibody molecule, and wherein the antibody and maytansinoid are chemically linked by a disulfide or thioether group, and wherein the antibody and maytansinoid are conjugated by a chemical linker, e.g., N-succinimidyl-3-(2- pyridyldithio)propionate, N-succinimidyl-4-(2-pyridylthio)pentanoate or succinimidyl-4-(N-maleimidomethyl)cyclohexane-1-carboxylate, and a composition comprising the immunoconjugate and a pharmaceutically acceptable carrier;
