The following is an examiner's statement of reasons for allowance: The prior art does not disclose a method and apparatus for towing an array of streamers wherein the apparatus predicts the positions of at least some of the streamer positioning devices; using the predicted positions to calculate desired changes in position of at least one streamer; and implementing some of the desired changes, generally as claimed.
