- II. Whether challenged claims 15, 27, 38 are unpatentable under 35 U.S.C. § 103(a) as obvious over Wang and Mozgrin.
- III. Reply to any arguments raised in Patent Owner's Response.
- IV. Respond to any issues specified by Patent Owner in its request for oral argument
- V. Respond to Patent Owner's presentation on all matters.
