Pursuant to 37 C.F.R. § 42.70(a), Patent Owner, Zond, LLC, respectfully requests oral argument at a place and time set by the Board. Oral argument is presently scheduled for June 12, 2015 (Paper No. 10, Scheduling Order).

The present proceeding involves U.S. Patent 7,604,716, which is also at issue in IPR2014-00807, IPR2014-01099, and IPR2014-01100. Concurrently with this request for oral argument, similar requests are being filed in each of these related proceedings. Patent Owner requests that, for the convenience of the parties and the Board, a single oral hearing be conducted on all the issues in these proceedings, as set forth below. To allow for a complete review of these issues, Patent Owner requests one hour of argument time.

#### **ISSUES TO BE ADDRESSED DURING ORAL ARGUMENT**

- A. Claims 1-11, and 33 are patentable under 35 U.S.C. § 102 over Wang (IPR2014-01099);
- B. Claims 12 and 13 are patentable under 35 U.S.C. § 103(a) over Wang and Lantsman (IPR2014-01100);
- C. Claims 14-18 and 25-32 are patentable under 35 U.S.C. § 103(a) over Wang and Kudryavtsev (IPR2014-00807);
- D. Claim 21 is patentable under 35 U.S.C. § 103(a) over Wang and Kudryavtsev (IPR2014-00808);

- E. Claims 19 and 20 are patentable under 35 U.S.C. § 103(a) over Wang, Kudryavtsev, and Lantsman (IPR2014-00808); and
- F. Claims 22-24 are patentable under 35 U.S.C. § 103(a) over Wang, Kudryavtsev, and Mozgrin (IPR2014-00808).
