Pursuant to 35 U.S.C. §317 and 37 C.F.R. § 42.72, and the Board’s authorization of March 9, 2015, Patent Owner ZOND LLC (“Patent Owner”) and Petitioners TAIWAN SEMICONDUCTOR MANUFACTURING COMPANY, LTD. and TSMC NORTH AMERICA CORP (jointly, “TSMC” or “Petitioner”) (collectively, “the Parties”) have settled their dispute and jointly request termination of *Inter Partes* Review No. IPR2014-00818, regarding U.S. 6,853,142 as to Petitioners TAIWAN SEMICONDUCTOR MANUFACTURING COMPANY, LTD. and TSMC NORTH AMERICA CORP. only. Because additional petitioners remain, the grant of this motion will not result in the termination of this *inter partes* review.
