- II. Whether challenged claims 8, 17 and 18 are unpatentable under 35 U.S.C. § 103(a) as obvious over Wang, Lantsman and Mozgrin.

- IV. Respond to any issues specified by Patent Owner in its request for oral argument.
- V. Respond to Patent Owner's Presentation on all matters.
