Pursuant to 37 C.F.R. § 42.70(a), Petitioner respectfully requests oral argument on the issues set forth below at a place and time set by the Board. Oral argument is presently scheduled for June 15, 2015 (Paper No. 32, Decision on Motion to Designate Lead Petitioner and Amend Scheduling Order). To allow for a complete review of the issues presented in this proceeding, Petitioner requests the ability to use a computer, projector, and screen to display possible demonstratives and exhibits. Pursuant to 37 C.F.R. § 42.70, Petitioner specifies the following issues to be argued:

- I. Whether challenged claims 7 and 20 are unpatentable under 35 U.S.C. § 103(a) as obvious over Iwamura, Angelbeck, Pinsley, and Wells.
- II. Whether challenged claims 9, 21, and 44 are unpatentable under 35 U.S.C. § 103(a) as obvious over Iwamura, Angelbeck, Pinsley, and Gruber.
- III. Whether challenged claim 38 is unpatentable under 35 U.S.C. § 103(a) as obvious over Iwamura, Angelbeck, and Pinsley.
- IV. Reply to any arguments raised in Patent Owner's Response.
- V. Respond to any issues specified by Patent Owner in its request for oral argument.
- VI. Respond to Patent Owner's presentation on all matters.
