ORDER SETTING DATE FOR PATENT OWNER PRELIMINARY RESPONSE
AND OPPOSITION TO MOTION FOR JOINDER

Conduct of the Proceeding
37C.F.R. § 42.5

On May 15, 2014, in IPR2014-00136, we instituted trial on challenges Reloaded Games, Inc. (“Petitioner”) asserted against claims 2-4, 6, 7, 10, 16-18, 20, 21 24, 24, and 29-36 of U.S. Patent No. 7,188,145 B2 (“the ’145 Patent”) owned by Parallel Networks LLC (“Patent Owner”). *Reloaded Games, Inc. v. Parallel Networks LLC*, Case IPR2014-000136 (PTAB May 15, 2014). On June 13, 2014, Petitioner commenced this proceeding (IPR2014-00950) by filing a petition challenging the claims on which we did not institute trial in IPR2014-00136 (Paper 3) and a Motion for Joinder with IPR2014-00136 (Paper 4). Petitioner’s challenges in IPR2014-00950 are based on references which formed the basis for instituting trial in IPR2014-00136.

A patent owner preliminary response must be filed within 3 months of the filing dated of a petition. 37 C.F.R. § 42.107(b). However, the Board may modify times set by rule, taking into account any statutory pendency goal. 37 C.F.R. § 42.5(c)(1). In view of the circumstances and the statutory deadlines in IPR2014-00136, Patent Owner may file a Patent Owner Preliminary Response and/or an Opposition to Petitioner’s Motion for Joinder not later than July 31, 2014.

In consideration of the above, it is

ORDERED that Patent owner is given until July 31, 2014 to file a Patent Owner Preliminary Response and an Opposition to Petitioner’s Motion for Joinder.
