On August 27, 2015, a conference call was held between Judge Lee and respective counsel for the parties. The parties requested permission to file a joint motion to terminate proceeding on the basis that all parties to this joined proceeding have settled. The parties also requested permission to file a request to file and to have kept their settlement agreement as confidential business information under 37 C.F.R. § 42.74(c). Both requests were *granted* in an order dated August 28, 2015. Paper 29.<sup>4</sup>

The parties were given until September 10, 2015, to file a joint motion to terminate and the corresponding request under 37 C.F.R. § 42.74(c). On September 10, 2015, the parties requested additional time to complete the filings. All parties agree that a short extension of time is necessary.

IT IS ORDERED that the deadline for filing a joint motion to terminate and the corresponding request under 37 C.F.R. § 42.74(c) is extended to September 17, 2015; and

FURTHER ORDERED that no additional extensions of time will be granted absent a showing of good cause.
