## Allowable subject matter

Claims 1-20, 22-27, 29-41, 43-46 are allowed.

The following is an examiner's statement of reasons for allowance:

The prior art neither discloses nor suggests an ionization source or a means that generates a weakly-ionized plasma from a feed gas, the weakly-ionized plasma reducing the probability of developing an electrical breakdown condition in the chamber such as required by claims 1, 22, 43, 44; a step of a method of ionizing a feed gas to form a weakly-ionized plasma that reduces the probability of developing an electrical breakdown condition in the chamber such as required by claims 10 and 33.
