DETAILED ACTION

This Office Action is in response to the Applicant's amendment submitted on June 03, 2010. In virtue of this amendment, claims 1-63 and 84-86 are cancelled; and thus, claims 64-83 remain pending in the instant application.

Information Disclosure Statement

1. The information disclosure statement (IDS) submitted on 06/15/2010 is in compliance with the provisions of 37 CFR 1.97. Accordingly, the information disclosure statement is being considered by the examiner.

Allowable Subject Matter

2. Claims 64-83 are allowed.
3. The following is an examiner's statement of reasons for allowance:
Prior art of record fails to disclose or fairly suggest the following limitations:
 - A method ... comprising ... "the voltage pulse having at least one of a controlled amplitude and a controlled rise time that increase an ionization rate so that a rapid increase in electron density" ..., in combination with the remaining claimed limitations as claimed in independent claim 64 (claims 65-73 are allowed as being dependent on claim 64).
 - A method ... comprising ... "the voltage pulse having at least one of a controlled amplitude and a controlled rise time that shifts an electron energy distribution in the plasma to higher energies that increase an ionization rate so as to result in a rapid increase in electron density" ..., in combination with the remaining claimed

limitations as claimed in independent claim 74 (claims 75-83 are allowed as being dependent on claim 74).
