DECISION
Motion for Joinder
37 C.F.R. § 42.122

GLOBALFOUNDRIES U.S., Inc., GLOBALFOUNDRIES Dresden Module One LLC & Co. KG, and GLOBALFOUNDRIES Dresden Module Two LLC & Co. KG (collectively, “GLOBALFOUNDRIES”) filed a Revised Petition in the above-identified *inter partes* review challenging U.S. Patent No. 6,806,652 B1 (Ex. 1201, “the ’652 patent”) owned by Zond, LLC (“Zond”). Paper 4. Pursuant to 37 C.F.R. § 42.122(b), GLOBALFOUNDRIES also filed a Motion for Joinder, seeking to join its proceeding with a proceeding filed by Intel Corporation (“Intel”)—specifically, joining IPR2014-01089 with IPR2014-00923. Paper 8.

On September 12, 2014, however, Intel and Zond filed a Joint Motion to Terminate and a true copy of their Written Settlement Agreement, made in connection with the termination, in accordance with 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(b), in each of Intel’s Proceedings that involved the ’652 patent. *See, e.g.*, IPR2014-00843, Paper 7, Ex. 1115; IPR2014-00923, Paper 7; IPR2014-00945, Paper 7. Upon consideration, we terminated those Intel Proceedings and entered Judgment in each Intel Proceeding. *See* IPR2014-00843, Paper 8; IPR2014-00923, Paper 8; IPR2014-00945, Paper 8.

The termination of Intel’s Proceedings renders GLOBALFOUNDRIES’s Motion for Joinder moot. Although in our previous Order, we authorized GLOBALFOUNDRIES to file a revised Motion for Joinder, GLOBALFOUNDRIES did not file such a Motion within the time period set forth in the Order.

In consideration of the foregoing, it is hereby

ORDERED that the Motion for Joinder filed in the above-identified GLOBALFOUNDRIES Proceeding is *dismissed as moot*.
