ARGUMENT AND REQUESTED RELIEF

Patent Owner Innovative Display Technologies LLC requests adverse judgment in *inter partes* review proceeding IPR2014-01097. The Board authorized Patent Owner to file a request seeking adverse judgment in a meeting held September 10, 2015.

Petitioner requested *inter partes* review of claims 1, 4–6, 16, 22, 23, 27, 28, and 31 of U.S. Pat. No. 7,300,194 (“the ’194 patent”) on July 1, 2014. Paper No. 2. The Board granted the Petition and instituted an *inter partes* review of all challenged claims on January 13, 2015. Paper No. 9 at 18.

“A party may request judgment against itself at any time during a proceeding.” 37 C.F.R. § 42.73(b). Accordingly, Patent Owner respectfully requests adverse judgment in this proceeding, and asks that the Board cancel all challenged claims, specifically claims 1, 4–6, 16, 22, 23, 27, 28, and 31 of the ’194 patent. 37 C.F.R. § 42.73(b)(2).


