Pursuant to the Board's Scheduling Order of January 9, 2015 (Paper 10 at 6), Petitioner requests oral argument be held on September 2, 2015. *See* 37 C.F.R. § 42.70(a). The Scheduling Order identifies September 2, 2015 as the date for the oral argument, if requested. *Id.*

Petitioner requests the ability to use audio visual equipment to display demonstrative exhibits, including the use of a projector and screen for a PowerPoint presentation.

- 5) Petitioner's response to Patent Owner's oral argument on all matters.
