A conference call in the above proceeding was held on July 30, 2015, among respective counsel for Petitioners and Patent Owner and Judges Jung, Powell, Kalan, and Lee. FURTHER ORDERED that Patent Owner is authorized to file a motion to expunge previously filed Exhibit 2052; no response is authorized.
