**PETITIONER NETFLIX, INC.'S  
REQUEST FOR REFUND OF POST-INSTITUTION FEE**

Pursuant to 37 C.F.R. § 42.15(a)(2), Petitioner Netflix, Inc. respectfully files this request for a refund of its post-institution fees. On August 1, 2014, Petitioner filed a petition for *inter partes* review of U.S. Patent No. 6,108,704, which was assigned Case No. IPR2014-01241.
