**MOTION TO WITHDRAW AS COUNSEL

I. Statement of Precise Relief Requested

Pursuant to 37 C.F.R. § 42.10 and authorization provided by the Patent Trial and Appeal Board (“the Board”) on November 10, 2015, Patent Owner Dragon Intellectual Property, LLC (“Dragon”) respectfully requests that the Board authorize withdrawal of its current counsel Jason S.
