**SONY CORPORATION OF AMERICA'S AND DR. CHEN-JEAN CHOU'S

PURSUANT TO 35 U.S.C. § 317**

Pursuant to 35 U.S.C. § 317(a), Petitioner Sony Corporation of America (“Sony”) and Patent Owner Dr. Chen-Jean Chou (“Dr. Chou”) jointly request termination of the *Inter Partes* Review of U.S. Patent No. 7,612,843, Case No. IPR2014-01268.

This *inter partes* review has not been instituted. Sony filed its petition for *inter partes* review on August 12, 2014. Dr. Chou has not filed a preliminary response, and one is not due until November 28, 2014. The parties have settled
