DECISION

Motion for *Pro Hac Vice* Admission 37 C.F.R. § 42.10



As authorized by the Notice of Filing Date Accorded to the Petition (Paper 4), Capella Photonics, Inc., ("Patent Owner") filed a "Motion for *Pro Hac Vice* Admission of Nicholas J. FURTHER ORDERED that Mr. Nowak is to comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Title 37, Part 42 of the Code of Federal Regulations, and that Mr. Nowak is subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq*.
