DECISION

Motion for *Pro Hac Vice* Admission  
*37 C.F.R. § 42.10*

As authorized by the Notice of Filing Date Accorded to the Petition (Paper 3<sup>1</sup>), Straight Path IP Group, Inc. (“Patent Owner”) filed a “Motion for *Pro Hac Vice* Admission” of Michael C. Newman (Paper 20).<sup>2</sup> Samsung Electronics Co., Ltd., Samsung Electronics America, Inc., and Samsung Telecommunications America, LLC (collectively, “Petitioner”) did not file an opposition to the Motion. Patent Owner’s Motion is *granted*. See 37 C.F.R. § 42.10(c); *see also Unified Patents, Inc. v. Parallel Iron, LLC*, IPR2013-00639, Order Authorizing Motion for Pro Hac Vice Admission, Paper 7 (October 15, 2003) (setting forth requirements for *pro hac vice* admission).<sup>3</sup>

It is

ORDERED that Patent Owner’s Motion for *pro hac vice* admission is *granted*, and Mr. Newman is authorized to represent Patent Owner as back-up counsel in IPR2014-01366, IPR2014-01367, and IPR2014-01368;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner as lead counsel in these *inter partes* review proceedings; and

FURTHER ORDERED that Mr. Newman is to comply with the Office Patent Trial Practice Guide and the Board’s Rules of Practice for Trials, as set forth in Title 37, Part 42 of the Code of Federal Regulations,
