

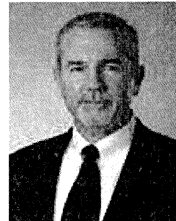

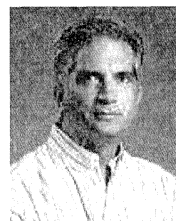

Chief Financial Officer

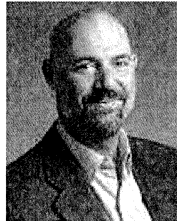
