Petitioner BlackBerry Corporation ("Petitioner") requests a refund of postinstitution fees in the amount of \$14,800.00 to be paid to deposit account number 15-0030.

On September 11, 2014, Petitioner filed a Petition for *inter partes* review of U.S. Patent No. 8,059,015. As required by 37 C.F.R. § 42.15(a), Petitioner deposited \$23,800.00 with the USPTO at the time of filing the Petition to cover associated fees.
