**Abstract**

This standard specifies the SCSI Architecture Model. The purpose of the architecture is to provide a common basis for the coordination of SCSI-3 standards and to specify those aspects of SCSI-3 I/O system behavior that are independent of a particular technology and common to all implementations.

# American National Standard
