On May 11, 2015, the Board authorized the following limited discovery of documents in the possession of EchoStar and Hughes: “1) legal bills demonstrating DISH involvement in the IPR proceedings, and 2) communications from DISH (not from other entities) related to drafts and approvals of IPR petitions.” (Decision on Motion, Paper 21, at 5.)
