


Motivation:

Conjecture:

If $E_0/N_0 > \gamma_0^{(1)}$, then as $n \to \infty$, the average maximum likelihood decoder bit error probability $\to 0$.

- (1) Necessarily, To > 0.485 dB (Shunnon limit, for Re's binary coles-)
- (2) Over all possible interleavers.
