Patent Owner's Responses were due July 8, 2015, in the above-identified proceedings. Patent Owner did not file a Patent Owner Response in any of these cases. Nor did Patent Owner arrange a conference call with the Board and opposing counsel per Board instructions to do so. *See Paper 37, 3.*<sup>2</sup>

Based on the record before us, we do not know whether Patent Owner has elected not to file a Response, or if Patent Owner has abandoned the contest. An abandonment of the contest would be construed by the Board as a request for adverse judgment, whereby all of the involved claims of the involved patents would be cancelled. 37 C.F.R. § 42.73(b)(4). If Patent Owner has abandoned the case, we would want to know this in order to administer these proceedings in an efficient manner.

Accordingly, it is

ORDERED that Patent Owner shall, no later than 20 days from the date of this order, file a paper limited to two pages in each case explaining whether Patent Owner (1) has elected not to file a Patent Owner Response, but has not abandoned the contest, or (2) has abandoned the contest with an explanation that Patent Owner understands such abandonment will lead to the cancellation of its involved claims under 37 C.F.R. § 42.73(b)(4).
