I, Jonathan D. Baker, hereby declare as follows:

1. I am a registered patent attorney (Reg. No. 45,708) with the law firm Farney Daniels, PC and am lead counsel of record for Patent Owner Memory Integrity, LLC ("Patent Owner," "Memory Integrity," or "MI") in Case Nos. IPR2015-00158, -00159, -00161, -00163, and -00172.

2. I submit this declaration in support of Patent Owner's Opposition to Petitioners' Motion to Correct Exhibit 1007 Pursuant to 37 C.F.R. § 42.104(c) (IPR2015-00161, Paper 14; IPR2015-00163, Paper14; IPR2015-00172, Paper 12).

The facts stated herein are based upon my personal knowledge and if called to testify I could and would do so competently as follows.

3. The entirety of Chapter 4 of "Interconnection Networks – An Engineering Approach" by Jose Duato *et al.* ("Duato") was absent from

Petitioners' version of Exhibit 1007 as served on Patent Owner and as filed with the Board. Nor was Chapter 4 of Duato served or filed in connection with any of the other pending *inter partes reviews* of U.S. Patent No. 7,296,121. Patent Owner did not receive a copy of Chapter 4 of Duato until Petitioners served their present motion to correct, on March 26, 2015.

4. Petitioners did not raise the issue of correction of Exhibit 1007 to add additional pages from Duato until March 17, 2015, when counsel for Petitioners emailed me to request Patent Owner's consent to the present motion. Such email did not attach or otherwise include any pages from Chapter 4 of Duato.

I declare under penalty of perjury that the foregoing is true and correct.
