PETITIONER REQUEST FOR REFUND OF POST-INSTITUTION FEES

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioners, Apple Inc. et al., request a refund in the amount of \$16,000 to be credited to Deposit Account Number 06-1050.

On October 28, 2014, Petitioners filed a Petition for *Inter Partes* Review of U.S. Patent No. 7,296,121 with the Patent Trial and Appeal Board that was assigned case number IPR2015-00172. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), Petitioner deposited an electronic payment in the amount of \$9,000 with the Board at the time of filing of its Petition to cover associated fees with Petitioner's *inter partes* review request, and a further \$16,000 in Post-Institution fees.

On May 11, 2015, the Patent Trial and Appeal Board entered a Decision denying institution of this proceeding. A subsequent request for rehearing was also denied. Accordingly, Petitioner requests a refund in the amount of \$16,000 for the post-institution fees that was paid to the USPTO in connection with that proceeding and request that the refund be credited to Deposit Account No. 06-1050.
