During the conference call, Patent Owner requested and was granted eight pages to file an Opposition (due December 3, 2014) to the joinder Motions, and Petitioner requested and was granted four pages to file a Reply thereto (due December 10, 2014), as a modification to previous page limits granted in a prior email communication (November 26, 2014).
