Petition for Inter Partes Review of U.S. Patent No. 7,418,504



Apple Inc. ("Petitioner" or "Apple") petitions for *Inter Partes* Review ("IPR") under 35 U.S.C. §§ 311–319 and 37 C.F.R. § 42 of claims 1, 2, 5, 6, 14-17, 19-23, 26-41, 43-47, and 50-60 ("the Challenged Claims") of U.S. Patent No. 7,418,504 ("the '504 patent"). By its accompanying Motion for Joinder, Petitioner seeks to join this petition to IPR2014-00614, a proceeding instituted on the same patent and the same prior art. This petition presents one additional ground relative to IPR2014-00614 establishing that dependent claim 5 is unpatentable. Claim 5 is highly similar to claims 23 and 47 involved in the -00614 proceeding – each claim specifies "authenticat[ing] the query" with claim 5 further specifying "using a cryptographic technique." Claim 5 is unpatentable over the same prior art that the Board has found to show the Challenged Claims unpatentable. See IPR2014-00614, Paper No. 9 at 17-21. It is submitted that consideration of this additional ground on a single claim will not impose a burden on the Panel given the common prior art and similarity to issues already being considered in the -00614 proceeding, as explained in the Motion for Joinder.
