DECISION

Motion to Withdraw Counsel

On November 21, 2014, Hulu, LLC (“Hulu”) requested authorization to file a motion for counsel to withdraw because the current lead counsel, Stacy Chen, was leaving the law firm of Keker & Van Nest, LLP. On December 1, 2014, the Board granted Hulu authorization to file a motion to withdraw Stacy Chen as counsel and concurrently file updated mandatory notices and an updated power of attorney. *See* Paper 6.<sup>1</sup> On December 3, 2014, Hulu filed an unopposed motion to withdraw Stacy Chen as counsel and substitute Mr. Leo L. Lam as counsel. *See* Paper 7. Hulu additionally filed updated mandatory notices and a new power of attorney. *See* Papers 8, 9. Hulu’s Motion is unopposed and Hulu confirms that there will be no changes to the schedule based on the change in counsel. Paper 6, 1.

## ORDER

It is, therefore,

ORDERED that Stacy Chen shall be considered withdrawn from this proceeding.
