**PETITIONER HULU, LLC'S UNOPPOSED MOTION FOR *PRO*  
*HAC VICE* ADMISSION**

UNDER 37 C.F.R. § 42.10(c)

Petitioner Hulu, LLC respectfully requests that the Board recognize Matthias A. Kamber, Esq., as counsel *pro hac vice* during this proceeding.

## I. BACKGROUND

Petitioner Hulu, LLC's Motion for *Pro Hac Vice* Admission is being filed in compliance with and pursuant to the "Order—Authorizing Motion for *Pro Hac Vice* Admission" in Case No. IPR2013-00639.

## II. STATEMENT OF FACTS

As a result, Mr. Kamber has established familiarity with the subject matter at issue in this proceeding, including extensive knowledge of the printed prior art submitted in the instant Petition and related matters.
