I. 37 C.F.R. § 42.8(b)(2) – Related Matters

The following proceeding results are related matters to U.S. Patent 5,954,781 and IPR2015-00276 (“the ’276 IPR”), and may affect a decision in this proceeding:

1. Case IPR2014-01247 – On January 6, 2015 the Board entered a judgment granting the Patent Owner’s request for the cancelation of claims 31 and 32, the challenged claims.
2. Case IPR2015-00290 – On February 4, 2015 the Board ordered the Petition dismissed on the grounds that none of the claims challenged by the Petitioner is a claim for which an *inter partes* review is provided for by 35 U.S.C. §311(b).
3. Reexamination 90/013,252 – On April 27, 2015 the United States Patent & Trademark Office (“USPTO”) issued a Notice of Intent to Issue a Reexamination Certificate for U.S. Patent No. 5,954,781. The USPTO confirmed, with the exception of claims 31 and 32 (which were statutorily disclaimed), the patentability of the patent claims at issue in the ’276 IPR.
