On April 5, 2016, Bandspeed, Inc. ("Patent Owner") filed Motions for *Pro Hac Vice* Admission of Adam G. Price in each of the proceedings. Paper 29.² In these motions, Patent Owner states that there is good cause for the Board to recognize Mr. Price *pro hac vice* during these proceedings because he has substantial experience with the patents at issue, and because he represents Patent Owner in related litigation in which the patents have been asserted. *Id.* at 2–3. Patent Owner represents that Petitioner does not oppose. *Id.* at 3.

The motions are supported by an Affidavit of Mr. Price attesting that he is a member in good standing of the Bar of the State of Texas, as well as in the Eastern and Western Districts of Texas, and the U.S. Court of Appeals for the Federal Circuit. Ex. 2003 ¶ 1. Mr. Price's Affidavit asserts that he agrees to "be subject to the Office's Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq.* and disciplinary jurisdiction under 37 C.F.R. § 11.19(a)." *Id.* ¶ 6.

Upon consideration, Patent Owner has demonstrated sufficiently that Mr. Price has sufficient legal and technical qualifications to represent Patent Owner in this proceeding.
