Pursuant to 35 U.S.C. § 317(a), Petitioner constituent Cellco Partnership d/b/a Verizon Wireless ("Verizon Wireless") and Patent Owner Solocron Media, LLC ("Solocron") jointly request termination of this case, No. IPR2015-00342, with respect to Verizon Wireless.
