



## JukeBoksi

On these pages you can browse ringtones made for certain Nokia GSM-telephones or yourself make your very own ringtone.

The service has been updated! With the new JukeBoksi you can publish any songs you like, as well as songs protected by authors' rights laws. Previously, already-published songs have been moved back into a song bank, from which you can publish them again. The price of the service has changed. Obtaining one ringtone from number **1559** costs **2.75** marks.

### What do I need?

You need a GSM telephone onto which you can upload ringtones or songs and a **Radiolinja connection**. Obtaining one ringtone from number **1559** costs **2.75** marks. Supported GSM telephones are Nokia 6110, 6150, 8810 (8110i and 9000i also play almost all tones well). **There can be only one song at a time on the telephone. When you load a new one from JukeBoksi, the previous song will be deleted from your telephone.**

**Warning!** On Nokia 5110, 3110, 2110 and 1610 telephones, among others, you cannot change or play your own ringtone, as the phone's manufacturer did not equip these phones with the necessary features. For this reason, ringtones made with JukeBoksi **do not work** on said phones. You can get more information on GSM phones and their features from your mobile phone dealer.

You can make your own ringtone using the Harmooni program, which functions best with the Internet Explorer 4.0.1 or Netscape 4.0.5 browsers. Using other browsers can freeze your computer! Your browser must have Java functionality connected.

If you haven't created ringtones before, you will have to first register as a JukeBoksi harmonizer. You can register on the [registration page](#).

Previous harmonizers can go directly to their own song bank.

Tarvitset GSM-puhelimen johon voi ladata soittoääniä eli biisejä ja **Radiolinjan liittymän**. Yhden soittoäänien hakeminen numerosta **1559** maksaa aina **2,75 mk.** Tuetut GSM-puhelimet ovat Nokia 6110, 6150, 8810 (myös 8110i ja 9000i soittavat lähes kaikki äänet oikein).

**Puhelimessa voi olla kerrallaan vain yksi biisi. Kun lataat JukeBoksista uuden, edellinen biisi poistuu puhelimestasi.**

**Huom!** Mm. Nokian 5110, 3110, 2110 ja 1610 -puhelimissa ei ole mahdollisuutta siirtää tai soittaa omaa soittoääntä, koska puhelimien valmistaja ei ole varustanut näitä puhelimia tarvittavilla ominaisuuksilla.
