On September 22, 2005, Verizon begins taking orders for FiOS TV in Keller, TX, and in Herndon, VA, on November 21, 2005. FiOS is a fiber to the premises (FTTP) telecommunications service. Availability of the Internet service has expanded to Massachusetts, New Hampshire, Rhode Island, New York, New Jersey, Indiana, Pennsylvania, Delaware, Maryland, Washington, D.C., Virginia, Florida, California, Oregon, and Washington. The FiOS TV service has launched in some of these states and will continue to expand its reach.

### Verizon Joins the Dow

As a result of its size and industry influence, Verizon becomes a component of the Dow Jones Industrial Average, one of the most closely watched U.S. benchmark indices tracking targeted stock market activity.

### Verizon Wireless Launches the 3G Network

Verizon Wireless launches its 3G (third generation) network in the United States. This revolutionary

### Verizon Communications Was Created

Bell Atlantic merged with GTE and changed its name to Verizon Communications Inc. The \$52 billion merger took almost two years to close, following approvals by Bell Atlantic and GTE shareowners, 27 state regulatory commissions and the FCC, and clearance from the U.S. Department of Justice and various international agencies. Vodafone AirTouch and Bell Atlantic Corp. received regulatory approval to combine their U.S. wireless assets, Bell Atlantic Mobile and AirTouch Communications. This \$90-billion joint venture began operations as Verizon Wireless.
