Pursuant to 35 U.S.C. § 317(a), Petitioner constituent AT&T Mobility LLC (“AT&T”) and Patent Owner Solocron Media, LLC (“Solocron”) jointly request termination of this case, No. IPR2015-00350.

This case is in the preliminary proceeding stage; no institution of a trial has been made. AT&T and Solocron have settled their dispute, including reaching agreement to terminate this *inter partes* review with respect to AT&T.

AT&T and Solocron have submitted a joint stipulated motion to dismiss the related matter in the District Court (*see* Petition § II.B) with prejudice as to AT&T Mobility LLC which is filed concurrently herewith as Exhibit 1088.
