**REQUEST FOR REFUND OF POST-INSTITUTION FEES FOR

On December 10, 2014, Apple Inc. (“Petitioner”) filed a Petition for *Inter Partes* Review of U.S. Patent No. 7,774,280 under 35 U.S.C. §§ 311-319 and 37 C.F.R. § 42.100 *et seq.* (“Petition,” Paper No. 1), seeking review of claims 1-5, 8, 11-16, 19, 22, 24-28, 31 and 34 of the ’280 patent.
