Pursuant to 35 U.S.C. § 317(a), Petitioner constituent Celco Partnership d/b/a Verizon Wireless (“Verizon Wireless”) and Patent Owner Solocron Media, LLC (“Solocron”) jointly request termination of this case, No. IPR2015-00380, with respect to Verizon Wireless.

This case is in the preliminary proceeding stage; no institution of a trial has been made. Verizon Wireless and Solocron have settled their dispute, including reaching agreement to terminate this *inter partes* review with respect to Verizon Wireless.

Solocron joins the present Motion solely for purposes of terminating Verizon Wireless’ participation going forward.
