On June 30, 2015, the parties filed a "Joint Motion to Terminate" based on a settlement agreement that resolves the parties' disputes related to the challenged patent. Paper 11.² The parties concurrently filed a copy of the settlement agreement (Ex. 1016) along with a "Joint Request that the Agreement Filed Separate as Exhibit 1016 be Treated as Business Confidential Information and be Kept Separate From the Files." Paper 12; *see also* 37 C.F.R. § 42.74(c) ("A party to a settlement may request that the settlement be treated as business confidential information and be kept separate from the files of an involved patent or application.").

We have not yet entered a decision on institution in either proceeding. Under these circumstances, we determine that it is appropriate to dismiss the Petitions. *See* 37 C.F.R. §§ 42.5(a), 42.71(a). This paper does not constitute a final written decision pursuant to 35 U.S.C. § 318(a).

ORDER

Accordingly, it is

ORDERED that the Joint Motion to Terminate is *granted*; and FURTHER ORDERED that the settlement agreement (Exhibit 1016 in IPR2015-00406 and Exhibit 1016 in IPR2015-00407) be treated as business confidential information and be kept separate from the files of the involved U.S. Patent Nos. 7,635,871 B2 and 7,643,168 B2.
