- Whether claims 1–8 and 12–14 of the '871 patent are unpatentable, under 35 U.S.C. § 103, because they would have been obvious over McNelley (Ex. 1006) and Umezawa (Ex. 1007).
- The appropriate construction to be given to the disputed claim terms;
- Reply to any arguments raised in Patent Owner's Response;
