Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211,4233-4234 (Jan. 18, 2013), Petitioner TRW Automotive US LLC ("TRW") requests a refund in the amount of \$7,600 to be paid to deposit account number 120600.

On December 19, 2014, TRW filed a Petition for *Inter Partes* Review with the PTO that was assigned case number IPR2015-00439. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), TRW deposited an electronic payment in the amount of \$24,200 with the PTO at the time of filing of its Petition to cover associated fees. TRW's payment consisted of \$9,000 in fees associated with TRW's Petition for *Inter Partes* Review request, and a further \$15,200 in Post-Institution fees.

On July 10, 2015, the Patent Trial and Appeal Board entered a Decision for IPR2015-00439 denying institution of claims 101 and 109. Accordingly TRW requests a refund in the amount of \$800 for the post-institution fees that it has paid to the USPTO in connection with the proceeding.
