**REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On January 5, 2015, Petitioner Praxair Distribution, Inc. and Praxair, Inc. filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,795,741 (Paper 1) requesting review of forty-four (44) claims. Petitioner paid a fee of \$39,400.00, including: (i) \$9,000.00 for an inter partes review request fee for up to twenty (20) claims; (ii) \$4,800.00 for an inter partes review fee for request of twenty-four (24) claims in excess of twenty (20); (iii) \$14,000.00 for an inter partes review post-institution fee up to fifteen (15) claims; and (iv) \$11,600.00 for an inter partes review post-institution fee for request of twenty-nine (29) claims in excess of fifteen (15).
