Pursuant to 35 U.S.C. § 317(a), Petitioner Dr. Reddy's Laboratories, Inc. ("DRL") and Patent Owner Fresenius Kabi USA, LLC ("Fresenius") jointly request termination of the *Inter Partes* Review of U.S. Patent No. 8,476,010, Case No. IPR2015-00715.
