[57] **ABSTRACT**

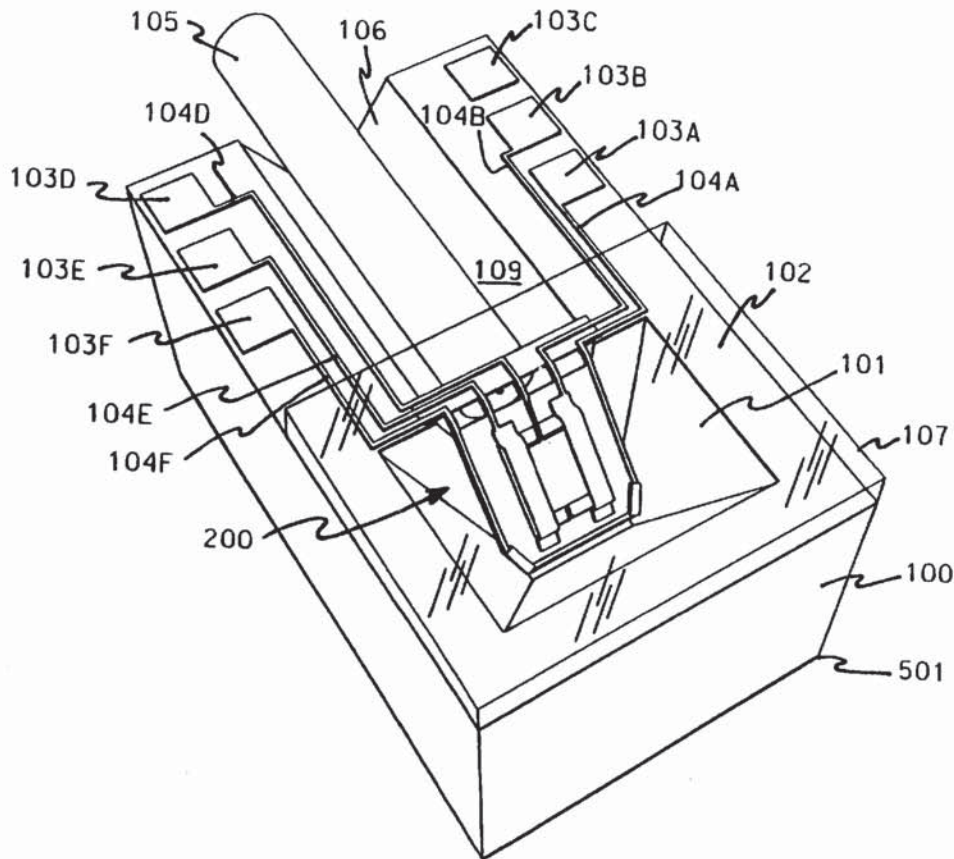

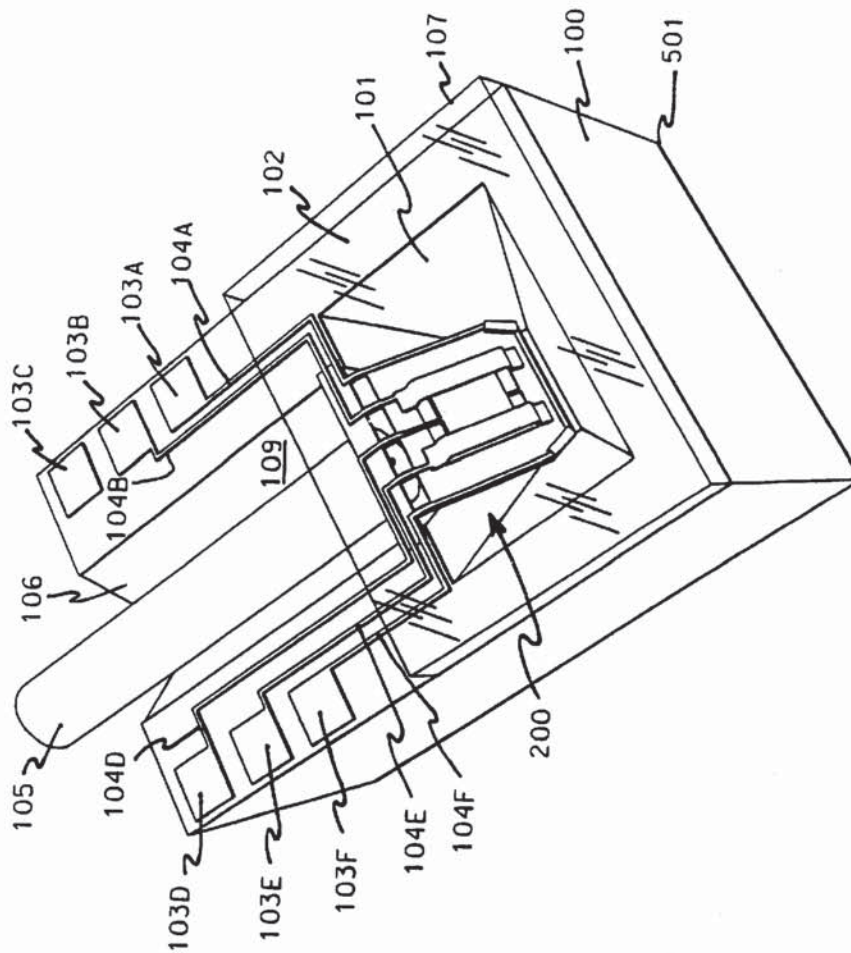

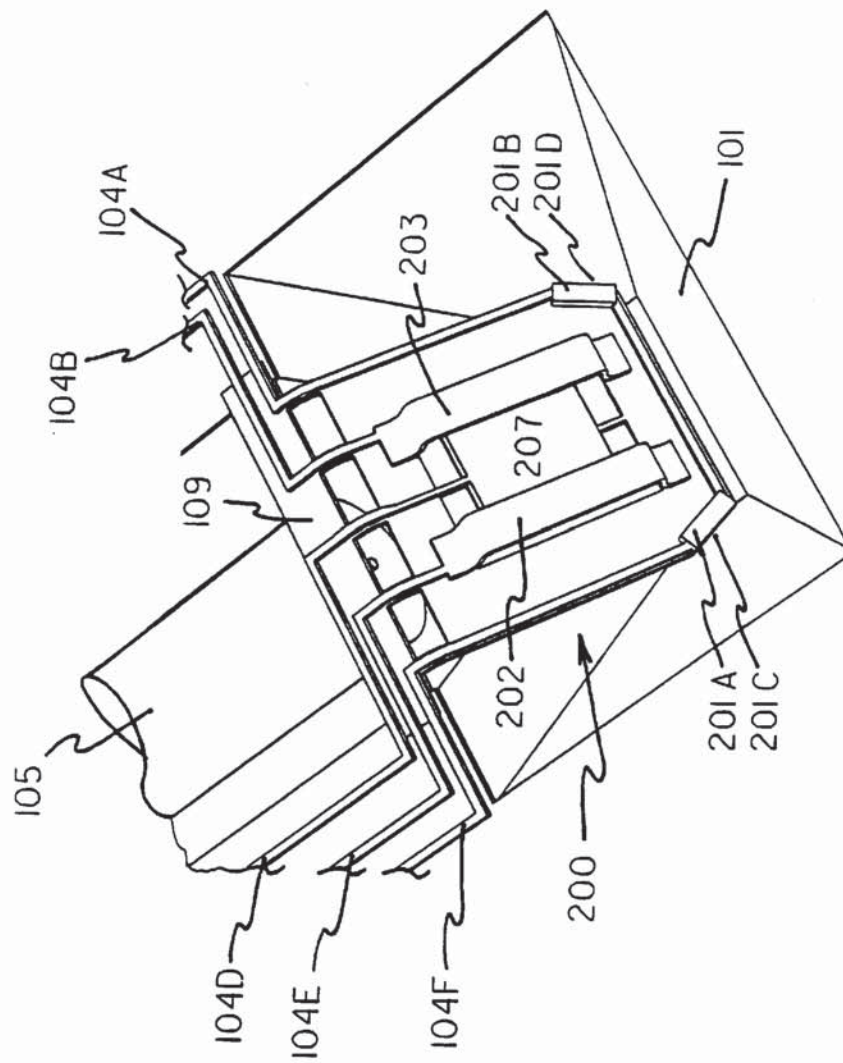

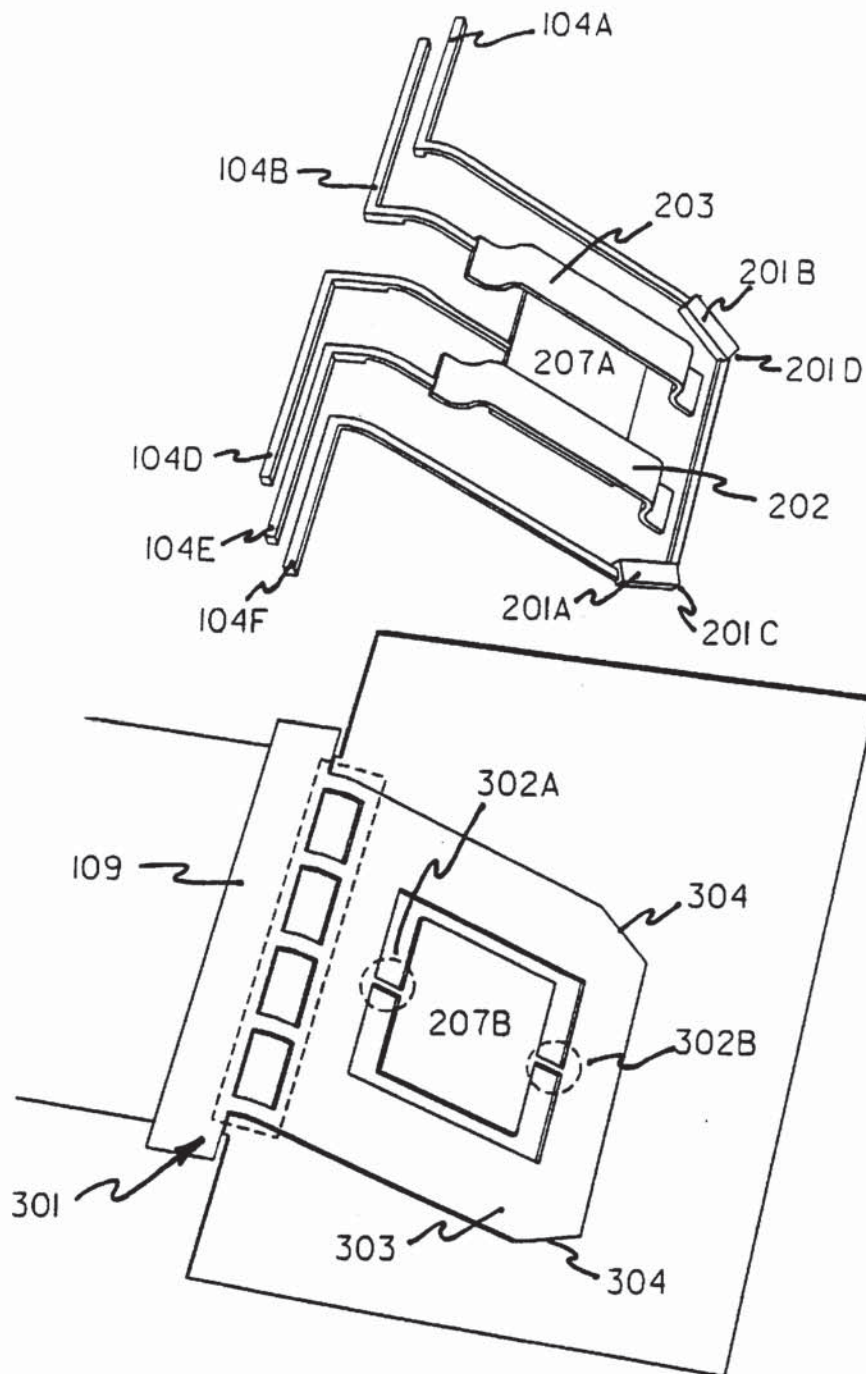

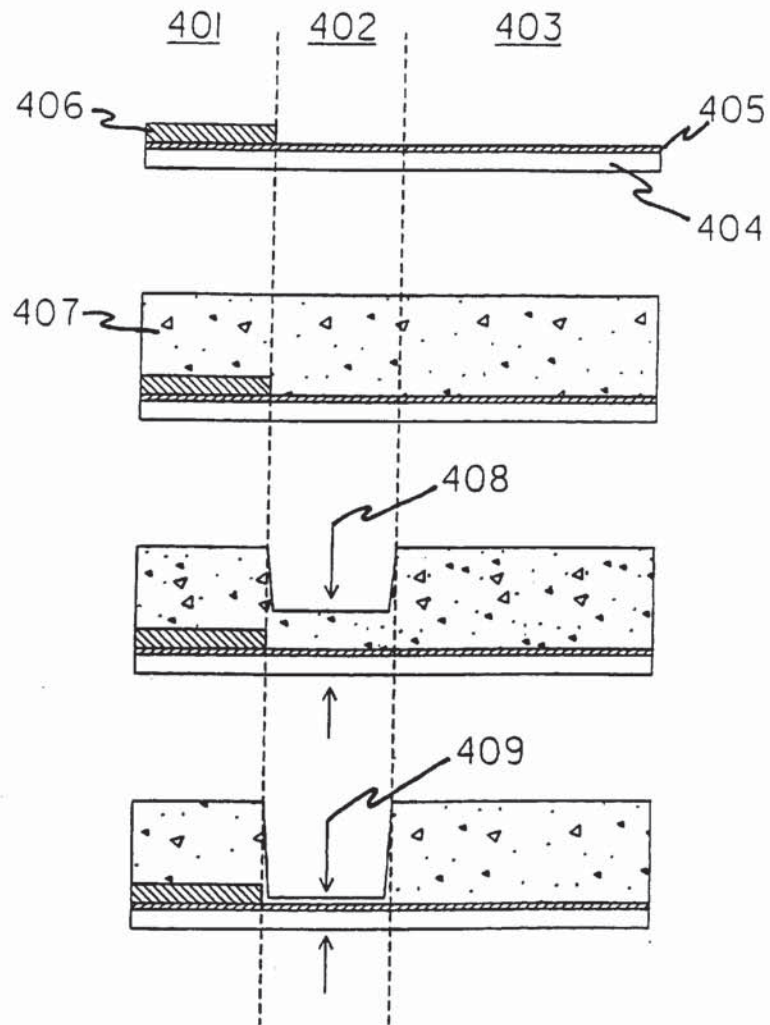
