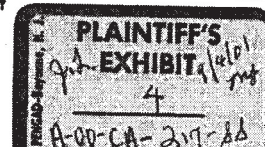

# Why Fibre Channel?

---

- **More devices**
  - Broader addressing range than SCSI-2
- **Faster transport**
  - Data rates up to 100MB/s vs. 20MB/s for fast/wide SCSI
- **Further distance**
  - 10Km possible on FC vs. 25m on differential SCSI
- **Extended capabilities**
  - Ability to transport IP, other data types

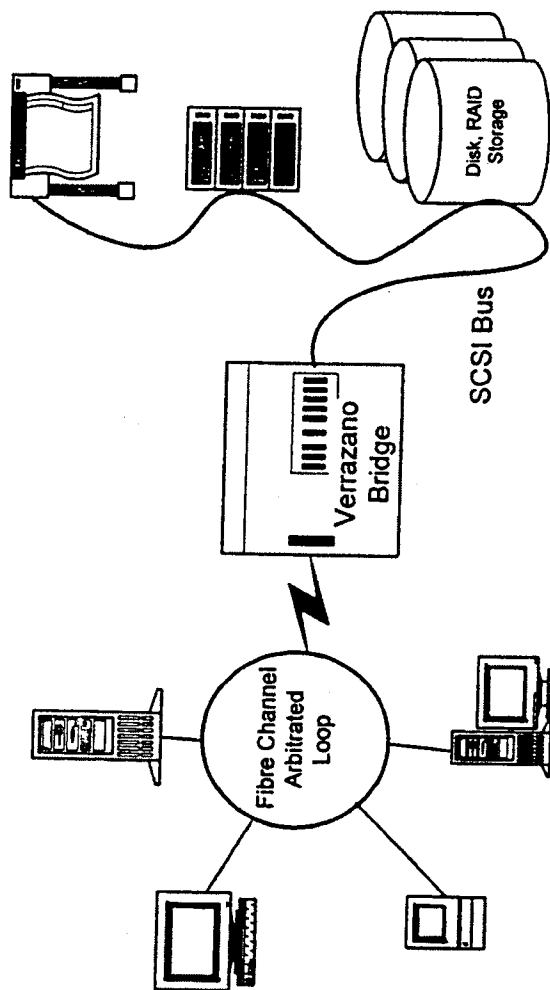
