DECISION

Motion for *Pro Hac Vice* Admission  
*37 C.F.R. § 42.10*

As authorized by the Notice of Filing Date Accorded to the Petition (Paper 7<sup>1</sup>), Paice LLC and The Abell Foundation, Inc. (collectively, “Patent Owner”) filed a “Motion for *Pro Hac Vice* Admission” (Paper 16, “Mot.”) of Daniel A. Tishman.<sup>2</sup> Patent Owner is expected to continue to have a registered practitioner as lead counsel. Ford Motor Company (“Petitioner”) does not oppose Patent Owner’s Motion. Mot. 2. It is

ORDERED that Patent Owner’s Motion for *pro hac vice* admission is *granted*, and Mr. Tishman is authorized to represent Patent Owner as back-up counsel in IPR2015-00606, IPR2015-00722, IPR2015-00785, IPR2015-00800, and IPR2015-00801;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner as lead counsel in these *inter partes* review proceedings; and
